5. SAHA Presentation on Jordan Court- Carrie Lutjens, SAHA

Informational Item

Discussion: Ms. Lutjens provided a presentation on Jordan Court development process. Mr. Denton asked for clarification on the parking space. Ms. Lutjens explains there are 20 spaces. 7 spaces dedicated for Affordable Housing staff and resident purposes and 12 spaces dedicated to All Souls and 1 van accessible space that cannot be dedicated. Mr. Denton asks for further details. Ms. Lutjens explains in the beginning of the project a portion of the parking garage would be shared betweenresidents and church staff/attendees. Mr. Denton asked what the purpose of the cost engineer?

Ms. Lutjens explains that it is standard of the accounting process in any project that uses tax credit. Chair Bruce adds, from the beginning it was always planned to have parking for both the church and housing residents. 13 spaces for the church and 9 for housing. Due to many variables, there are not many spaces available. There are 7 spaces for Jordan court, is this correct? Ms. Lutjens confirms the parking spaces went down for both the housing residents as well as for the church. Vice Chair DeHollander asked if the staff report will address original applications? Ms. Sweeney responded that in the staff report HCD is going to contextualize this project with regards to HCD portfolio. Mr. Denton asks what amount did the project receive in net revenue from sale of the tax credit? Ms. Lutjens shares the total estimated tax credit equity used on the project was \$8,049,705. Mr. Denton asked what amount of the \$8 M was credited to the parish? Ms. DeHollander asked for understanding as to how as a committee how it applies to the oversight of A1 funds? Mr. Denton asked what the amount is dedicated to nonqualified construction. Ms. Lutjens answered \$4.8Mil. Mr. Denton asked if 50% of the tax credit proceeds went for nonqualified use? Ms. Lutjens answered non-A1 eligible use. Chair Bruce asked HCD staff if it's unusual for a project that receives both county funds and tax credit equity to have other uses on site besides affordable housing? Mr. Sweeney responds, yes. HCD has lots of projects that have mixed-use. There are different types of use, private, public, nonprofit and commercial.

Mr. Sweeney provided a presentation on Jordan court.

Mr. Gumataotao asked if the committee would have access to the data shared. Mr. Sweeney responded that it will be shared with the committee members. But is also available on the

Measure A1 affordable housing website. Ms. Fitts asked for the next report to include contextual information.

Chair Bruce asked what the definition of a disadvantaged worker is. Ms. Jones
responded, a disadvantaged worker, now called equity priority workers. They
are workers who cover several different populations. If they're AMI, if they're
household AMI is under 80%, they could be a veteran, youth, someone in an
apprenticeship program, reentry person, Homeless person. Also, someone
receiving state assistance.

7. Update on Alameda County HCD News- Dylan Sweeney, Housing and Community Development Manager, Alameda County Community Development Agency (CDA)

Informational Item

Discussion: Mr. Sweeney provided an update on general news in HCD.

• Mr. Gumataotao asked where the committee can find the application. Mr. Sweeney responded it is on a link on the HCD website. Chair Bruce asked Mr. Sweeney if it is only for the unincorporated county. Mr. Sweeney responded its funded through the ARPA funds which have been designated for the use in the unincorporated county. It supports businesses that operate unit there. Mr. Denton asked if these programs being done through A1 funding? Mr. Sweeney responded, No. Mr. Denton shared his concern being that bonds are a long-term source of funding, and these are short term needs. Mr. Sweeney responded bond funds are not eligible for use for noncapital needs in the state of California. HCD cannot fund program with bond funds. HCD does leverage bond funds to make affordable housing structures and facilities that make affordable housing structure and facilities that are compatible with programming.

Discussion: Mr. Sweeney provided an update on Measure A1 news, rental development lease-up information, Elations contract information, and Annual Report 4.

• Chair Bruce shared she would like a preview of Doorway to be shared with the committee. Mr. Denton asked if HUD restricts residents of the units that are built with tax credit proceeds that they only be available to US citizens. Is this true here in California? Mr. Sweeney answered, status households' changes from administration to administration. In Alameda County we work with the community's citizens regardless of citizenship status. Vice Chair DeHollander asked to see the businesses, the impact of the kind of work that we are doing. Mr. Gumataotao commented on the information he found on the Oversight web page. Seems information is outdated. Mr. Sweeney confirmed that it is outdated and shared the correct information with the committee staff. Mr. Gumataotao shared that in the future if the electronic materials sent by the HCD staff could include links to easier find data.
