	Just Cause	Emergency Circumstance
Reason for teleconferencing must be disclosed to the legislative body?	Yes. (Gov't Code § 54953(f)(2)(A)(i)).	Yes. (Gov't Code § 54953(f)(2)(A)(ii)).
Reason for teleconferencing must be approved by the legislative body?	No. (Gov't Code § 54953(f)(2)(A)(i)).	Yes. (Gov't Code § 54953(f)(2)(A)(ii)).
When does a teleconference request have to be made?	At the earliest opportunity. (Gov't Code § 54953(f)(2)(A)(i)).	As soon as possible. If there is insufficient time to make the request before the posting of the public agenda, then the request may be made at the beginning of the meeting. (Gov't Code § 54953(f)(2)(A)(ii)(I) & (II)).
	Yes. A member may not use this option more than two times per calendar year. (Gov't Code § 54953(f)(2)(A)(i)).	Yes, total remote appearances may be for no more than three consecutive months or 20 percent (20%) of the regular meetings of the calendar year.
Annual limit on the use of the teleconference option?	Legislative body members may not use a combination of "just cause" and "emergency circumstance" to participate remotely for more than three months or 20 percent (20%) of the regular meetings of the calendar year. If the legislative body convenes fewer than 10 times a year, the member cannot participate remotely in more than two regular meetings. (Gov't Code § 54953(f)(3)).
