I. Call to Order

The meeting was called to order at 3:05 PM by Mary Anne Reno.

II. Approval of Minutes (1/9/2025)

A motion was made by Borjon to approve the minutes for the January 9, 2025, meeting. Karki seconded the motion. 1 abstained, 3 in favor. **The motion was approved.**

III. HCDAC Meeting Time

The discussion of the HCDAC meeting time was moved up in the agenda to accurately approve the Consolidated Plan Schedule dates. IV. Public Hearing on HOME Consortium Consolidated Plan

Karki made a motion to adopt the proposed Consolidated Plan schedule as well as format allowing for on-line submission and adopt the proposed Consolidated Plan priority areas and five-year objectives, subject to changes/additions made by the HOME TAC, Urban County TAC and citizen comments. Tinsley seconded the motion. **The motion was approved.** The public hearing was closed at 3:23 pm.

V. Public Hearing on the FY25-FY29 Regional Analysis of Impediments to Fair Housing Choice

Chari Reno opened the Public Hearing at 3:25 pm. Katie Alducin presented the Staff Report on the FY54-FY29 Regional Analysis of Impediments to Fair Housing Choice. There were no comments received from the public. Borjon made a motion to adopt the Regional Analysis of Impediments to Fair Housing in substantially the form submitted. Tinsley seconded the motion. **The motion was approved.** Members expressed appreciation for the comprehensive report and plan. The public hearing was closed at 3:31 pm.
