


## TELECONFERENCING GUIDELINES FOR PUBLIC PARTICIPATION IN THE COUNTY OF ALAMEDA MEASURE A1 HOUSING BOND CITIZEN OVERSIGHT COMMITTEE

Members of the public may appear in-person and participate in meetings of the County of Alameda Measure A1 Housing Bond Citizen Oversight Committee. Alternatively, members of the public may choose to view meetings and participate remotely through teleconference. **Members of the public who choose remote participation may participate in the meetings and address the Committee during the meetings in the following ways:**

### Public Comment via Teleconference

Members of the public may address the Committee regarding matters on the agenda and during the Public Comment portion of the meeting for matters not on the agenda. Matters not on the agenda must be within the Committee's subject matter jurisdiction.

  - If you decide not speak, you may hang up and dial back into the meeting or simply notify the Clerk you do not wish to speak when you are unmuted and asked to speak.
